- 3. The application form and all required documents must be competed and received at Branch 36 Headquarters NO LATER THAN MARCH 22, 2024.
- 4. The applicant must be sure to include the SAT ENROLLMENT CODE NUMBER for the Lepper/Fink/Zwoboda/Sombrotto Scholarship Fund, which is S.A.T. 0573. Indicate your request to release the SAT scores to the Scholarship Chairman of Branch 36, when registering for the S.A.T. tests.

METHOD OF SELECTION:

The recipients of the awards will be determined by the result of the Scholarship Aptitude Test (SAT) and the three-year academic record.

The Vincent R. Sombrotto, Branch 36 NALC, does not guarantee admission to any college. The applicant is required to make an independent application to the college or university of her/his choice and must meet all requirements for admission.

Payments for Scholarships will be made for tuition only and not for room and board, directly to the Bursar of the college of the winner's selection upon certification of the award winner's registration. Continuance of this Scholarship is dependent upon the winner's maintaining satisfactory scholarship grades at his/her college during a consecutive four-year period.
